SUBJECT: GRANT OF PREMATURE INCREMENT ON PROMOTION WITHIN THE SAME SCALE.

I am directed to refer to the subject cited above and to say that under Rule 10(2) of Azad Jammu & Kashmir Civil Servants Pay Revision Rules, 1977, one advance increment is admissible to the Civil Servants, at the time of their promotion to higher posts, who are already drawing pay in the basic pay scales of the higher posts.

2- Now, in pursuance to the Government of Pakistan, Finance Division Islamabad Office Memorandum No. F. 11(30) R-2/2010-1150 dated 5th November, 2012 (copy enclosed), the competent authority is pleased to allow one premature increment in the pay scales of the higher post in fixation of pay on promotion within the same pay scale in all cases of promotion to higher posts carrying the same basic scales, meaning thereby that one advance increment as next stage and another as a premature increment will be admissible in such cases of promotion.

3- The expenditure for the purpose shall be borne within sanctioned budget of concerned departments, however, arrears shall not be allowed.
